Prior to this, Tuttle was director of the Northeast Regional Resource Center, health and education services, in Beverly. Tuttle earned a Masters of Nonprofit Management from Regis University and a BS from Metropolitan State College. He is also a member of Children's Service, CEO/Leadership Committee for the Association for Behavioral Healthcare, vice chair of the Department of Youth Services Provider Group, and a Board member for the Children's League of Massachusetts.
